1. **NAME OF THE TRUST**
The trust created by these presents shall be known as "Thakur Chandrapal Singh Charitable & Education Welfare Trust."
2. **TRUST FUND**
In order to effectuate the said desire the settler has made over the trustee a sum of Rs.11,000/- (Rupees Eleven thousand only) to hold the name together withal other properties that may be acquired out of the same or otherwise and may thereafter be subject to the trust (hereinafter referred to as the TRUST FUND) for the object and purpose hereinafter expressed with the powers and on the terms and conditions herein contained concerning the same.
3. **REGISTERED OFFICE**
The registered office of the trust will be located tat Vill Bhaishaha, Post Bhopatpur Chowki, Distt. Bahraich, U.P. or at such other place as the trustees may decide from time to time.
4. **AREA OF OPERATIONS**
The area of the operations of the trust shall be india.
5. **AIMS & OBJECTIVES**
Object of the trust shall be public charitable purposes and its income shall be applied of accumulated in India only for public charitable purposes not inconsistent with any of the provision if Income Tax Act., 1961 and any other statutory modification there of and without prejudice to the generality of the aforesaid the following shall be deemed to be the principal objects:- (without any discrimination of caste, creed, religious, Society or gender)
 - a) To establish, develop maintain and grant aid in cash or in kind to hospitals medical schools, medical colleges, nursing institution, dispensaries, Maternity homes, Child welfare centers. Teachers training Institute and studies and /ro such other similar Charitable institutions in India for the benefit and use or the general public.
 - b) To establish, run support and grand aid or other financial assistance to schools, colleges hospitals, Libraries, reading rooms, Universities, laboratories, research, hostel for schedule cast like nature in India & other backward classes children/ people and other institution of the like nature in India, for use of the student and staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

- c) To establish maintain and run studentship, Scholarship, and renders other kind of aid to students including supply of books, stipends medals and other incentives to study without any distinction as to cast, colour, race creed or sex.
- d) To promote establish, support maintain or grant aid to institution for the promotion of science, literature, music drama and fine arts, for the preservation of historical monuments and for the research and other institutions in India, having similar objects for the benefit of the public in general.
- e) To establish, maintain or grant and for the establishment and / or maintenance of parks gardens, gymnasiums, sports clubs dharamshalas and rest houses, for use by public in general.
- f) To establish, maintain or grant aid to homes for the aged or orphanages, establishment for the relief and help to the poor needy and destitute people, orphans widows and aged persons.
- g) To establish and develop institution for the physically handicapped and disabled or mentally retarded person and to provide theme education food clothing or other help.
- h) To grant relief and assistance to the needy victims, during natural calamities such as famine, earthquake, flood, fire, pestilence etc. and to give donations and other assistance to institutions, establishment or persons engaged in such relief work.
- i) To construct, repair and manage the marghats cemeteries and burial grounds.
- j) To grant aid or render assistance to other public charitable trust or institutions.
- k) To do all such other things and acts as are incidental or conducive to be deemed necessary for the attainment of the objects of the trust and to do all public charitable works as may so required including the help of government whether state or Central.
- l) To subscribe and to become member to co-operate with any institute, to do all such other things and acts as are necessary for the attainment of the objects of the trust.
- m) To merge or affiliate itself with any other institution establish for objects wholly similar to its own.
- n) To acquire and/ or take over and/or purchase and/or sell and or lease and/ or mortgage any moveable property properties and utilize the same for charitable purpose of the trust.

6. **BOARD OF TRUSTEES**

- The management and control of the trust and the trust properties shall vest in the board of Trustees which shall comprise of not less than two and not more than seven trustees including the chairman and the Managing Trustees. All the Declarants herein will be the First Trustees. The Board of Trustees shall determine the strength of the Board from time to time.
- The tenure of the first Board of trustees shall be for a period of five years and provisions for retirement of such board of Trustees shall be applicable in respect of them only after first five years.
- All other trustees to be appointed subsequently will hold office for a period of three years after which one third of them shall retire by rotation of the basis of their seniority.

7. **RETIREMENT**

In case any trustee wants to retire he can do so by giving three months prior notice in writing to the board of trustees and in that case the settler shall nominate any person whom he may though expedient.

8. **APPOINTMENT OF NEW TRUSTEES**

The appointment of the new trustees shall be governed by the rules as follow:

- After the completion of the tenure of office of the Trustee, the shall retire but shall be eligible for reappointment.
- In case of vacancy/ vacancies, new trustees shall be appointed from among the representatives of voluntary organizations, funding agencies and independent experts in the field of development, finance, legal and other related matters.
- Filling in of vacancies shall be by a decision of the Board of Trustees. As far as possible, efforts shall be made to fill in the vacancies by unanimous decisions failing which the majority decision shall prevail.
- And as often as the trustees of THESE PRESENTS shall die or desire to retire or refuse of become incapable to act in the trust thereof shall take the benefit of the insolvency law for the time being in force of if any trustee shall remain absent from three consecutive lawful for the surviving of continuing trustee or trustees for the time being of THESE PRESENTS to appoint new trustee so vacating their offices in the Board of Trustees.

9. **EFFECT OF APPOINTMENT OF NEW TRUSTEES**
Upon every such appointment made in pursuance of the last forgoing clauses thereof the newly appointed Trustees shall have powers and authorities of a trustees under THESE PRESENTS.
10. **POWER TO APPOINT COMMITTEES**
The Board of Trustees shall be entitled from time to time to appoint with or without remuneration and on such term and conditions as they may think proper, to appoint Committee as they may think proper to function under the Authority and control of the Trustees for carrying out the objects of the Trust of these presents or the management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the objects of the Trust.
11. **POWER TO DETERMINE ALL QUESTIONS OF DOUBT OR DIFFICULTY**
It shall be lawful for the Board of trustees to settle and determine all matters of interpretation of THESE PRESENTS as well as matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the trusts and powers of THESE PRESENTS and any such settlement or determination shall be valid, hiding and conclusive and shall not be objected to or re-opened upon any ground whatsoever.
12. **POWER TO COMPROMISE**
The board of trustees shall have full powers to settle compromise of compound, out of court of trust action and other proceedings and to settle all or other proceeding, difference of demand and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.
13. **POWER TO PURCHASE, HIRE OR TAKE ON LEASE**
The Majority of trustees shall be entitled to purchase of hire or to take on lease a property or properties for the purpose of the carrying out the objects of the Trust hereby created.
14. **POWER TO BORROW**
The trustees may from time to time, at their discretion for the furtherance and carrying out the objects of the Trust of THESE PRESENTS, borrow sum as may be determined by the Board of Trustees from time to time in form and manner thereupon. The Trustee shall, at their

discretion, make all such dispositions of the properties movable or immovable forming part of the Trust Fund or any part thereof and enter into such agreements, assurances and things in relation thereto as the Trustees may deem proper for giving security for such loan and interest.

15. INVESTMENT OF TRUST FUND

All money forming part of the Trust fund and requiring investment shall be invested and the securities authorized by law for investment of Trust funds which are permissible under section 11(5) of the Income Tax act, 1961 or shall at their discretion sell and/or realize the same of any part thereof.

16. IN WHOSE NAME MONEY TO BE INVESTED

All money forming part of the Trust fund and requiring investment shall be invested and the conveyance of assurance in respect of any immovable property/properties forming part of the Trust Fund shall be obtained in the name/names of the Trustees for time being to the Board of Trustees. Later on in the name of the trust as Thakur Chandrapal Singh Charitable.

17. OPENING BANK ACCOUNT

The Board of Trustees of Thakur Chandrapal Singh Charitable & Education Welfare Trust may open any banking account or accounts with such scheduled bank as may from time to time be determined by the trustees and shall forthwith pay or cause to be paid the rents, income dividends and all other money forming part of the Trust Fund to the credit of any such account or accounts and such accounts or account shall be operated upon by the SETTLOR of the trust individually.

18. ACCOUNTS AND AUDIT

The Trustees shall maintain regular accounts of the trust funds and shall get the same duly audited by a firm of Chartered Accountants. The Accounts and Audit Report and report of the Trust shall be made up at least once in a year covering the accounting period as may be determined by the Board of Trustees from time to time.

19. POWER TO SELL THE IMMOVABLE PROPERTY AND MANAGE

- a) The Majority of Trustees shall have the power to buy, acquire, take on lease any property movable and immovable that may be needed to carry out and further the objects of the Trust and incur all such expenses connected therewith.
- b) The Majority of Trustees shall, manage any immovable property or properties for the time being forming part of the Trust Fund in such manner as they shall think fit with full power to make improvement, repairs or alteration of any description and to make or incur any

outlay for any such purposes of for the insurance or otherwise for the protection of benefits of the said premises and to go grant or renew leases or tenancy or occupation and to make any agreements with tenants of occupiers or intending tenants or occupiers.

- c) The Majority of Trustees shall, if the need arises, sell or assign or lease any movable or immovable property or properties for the time being forming part of the Trust Fund together or in parts for the purpose aforesaid or any of them to execute and do all such assurances, acts, suits and things as they shall think fit.

20. **POWER TO AMEND THE RULES**

If in the opinion of the Trustees, circumstances so require, the Trustee may by majority make any amendment in the rules, they may consider necessary for the better management at or administration of the Trust activities of for carrying out the objects of the Trust.

21. **POWER OF MAKE RULES AND REGULATIONS**

In addition to the aforesaid rules, the Trustees, shall from time to time, be entitled to make rules and regulations for the administration and management of the Trust of THESE PRESENTS and all matters incidental to or concerning the same PROVIDED, such rules and regulations shall not be repugnant to or be inconsistent with the provisions of the purposes of the Trust thereof.

22. **POWER OF AMALGAMATE OTHER TRUST OR VICE VERSA**

Trustees shall be at liberty to allow or to be allowed and permit, or to be permittee to amalgamated with any other Trust, Institution or charity, in any areas or area whose objects are the same or similar to those of THESE PRESENTS, PROVIDED they are not inconsistent with or repugnant to the object thereof.

23. **POWER TO REIMBURSE**

The Trustees of THESE PRESENTS will not be entitled or receive any remuneration as trustees but will be entitled to reimburse and also to pay and discharge out of the Trust Fund all expenses incurred by them or on their behalf in or about execution of the Trusts and power of THESE PRESENTS in accordance with in the decision of the Board of Trustees.

24. **OTHERS**

- a) The trust shall, accept in cash or kind, donations, gifts, grants, contributions (as Corpus as otherwise) and to collect interest and other income of the trust for being utilized for furtherance of the aims and objectives of the trust.
- b) The trust shall pay all expenses preliminary or incidental to the formation of the trust and its registration and for management and administration for the same.

- c) In the event of winding up of the trust, the corpus of the trust will be transferred as per decision taken by majority of trustees. Nobody other than majority of trustees will be entitled to take decision regarding assets, liabilities and corpus fund of trust at the time of winding up of trust.
- d) In case of difference of opinion arising among the Trustees and in all matters wherein the Trustees have a discretionary power, the opinion of the majority of all Trustees present and voting shall prevail and be binding of the majority as well as on those who may have not voted.
- e) The trust shall do all such acts, deeds and things and extends all such other assistance to the said voluntary organizations as may be necessary and incidental to the attainment of the aforesaid objects.
